

Please notice that the word "TIMES" in Daniel 7:25 is plural which means that not only would the beast power of Daniel 7 think to change the weekly TIME but the annual TIMES as well. Satan, Rome and the Jesuits hate it when God's remnant people meet to worship their creator and fellowship with one another at the specific times specified in Leviticus 23 for Satan knows full well that when we do meet at these specific times we will be better educated to recognize his ever increasing delusions and deceptions and that we will be strengthened to withstand his temptations and eventually be sealed unto everlasting life when we spend more time with the Groom at His appointed times.

In a video presentation towards the end of this article Walter Veith talk tickles the ears of his awestruck fans by chopping the law into pieces. He discusses the "health laws" but conveniently forgets the passage from Exodus 15:26 which teaches that if we desire to avoid the diseases that God brought upon the Egyptians then we must keep **ALL** of the statutes listed in the law of God also known as the law of Moses.

Exodus 15:26 And said, If thou wilt diligently hearken to the voice of the LORD thy God, and wilt do that which is right in his sight, and wilt give ear to his commandments, and **keep ALL his STATUTES**, I will put none of these diseases upon thee, which I have brought upon the Egyptians: for I am the LORD that healeth thee.

Most Christians including many, many of my fellow Seventh-day Adventists do not take the time and effort to fast and study their Bibles with determination to discover for themselves what the word of God teaches. They are content to go to services once a week, listen to their pastors and agree with everything they say without thoroughly investigating the Scripture for themselves as if their very life depended on it. Because this is the case, most have not discovered that the Bible unambiguously teaches that it is the "**wicked**" that are teaching others that the statutes/feast days are "non essential for salvation" or "are not necessary to be observed in the New Testament era."

"Salvation [is] far from the wicked: for they seek not thy statutes."
Psalms 119:155

Here King David makes it plain as can possibly be that **it is the wicked that do not seek the statutes and he also makes it certain that "salvation is far from the wicked."** So King David's inspired words are of more value to the serious Bible student than any modern Bible teacher that teaches that we are no longer required to observe the statutes/feast days of God.

Definition of the word "statute"

Strong's Hebrew word number H2708

Feminine of **H2706**, and meaning substantially the same: - **appointed**, custom, manner, ordinance, site, **statute**.

From H2710; an enactment; **hence an appointment (of time, space, quantity, labor or usage)**: - appointed, bound, commandment, convenient, custom, decree (-d), due, law, measure, X necessary, ordinance (-nary), portion, set time, statute, task.

We see here from Strong's definition of the word statute that the primary definition is "**an appointment of time.**" So to say that **one believes in the statutes while simultaneously rejecting the annual feast days is an oxymoron and an absolute impossibility. Also, along the same line of reasoning, to claim to obey the so called "health laws" while simultaneously teaching people to NOT keep the feast days is an oxymoronic concept and an impossibility because the feast days are health laws.** It is always healthy to obey God and the commanded social interaction based upon Godly, Biblical principles that the feast days provide is one of the healthiest things we can possibly do.

Not all statutes are feast days but the feast days are definitely statutes

Leviticus Chapter 23 tells us four times that the feast days are statutes:

1. 23:14 And ye shall eat neither bread, nor parched corn, nor green ears, until the selfsame day that ye have brought an

offering unto your God: [it shall be] a **statute** for ever throughout your generations in all your dwellings.

2. 23:21 And ye shall proclaim on the selfsame day, [that] it may be an holy convocation unto you: ye shall do no servile work [therein: it shall be] a **statute** for ever in all your dwellings throughout your generations.
3. 23:31 Ye shall do no manner of work: [it shall be] a **statute** for ever throughout your generations in all your dwellings.
4. 23:41 And ye shall keep it a feast unto The Lord seven days in the year. [It shall be] a **statute** for ever in your generations: ye shall celebrate it in the seventh month.

I believe it is more than a happenstance that the word statute is used 4 times in Leviticus chapter 23 when we consider that these statutes were given specifically to guard the fourth commandment of the Decalogue.


So the truth is that feast days are statutes but not all statutes are feast days and according to king David our salvation is absolutely connected to seeking the statutes/feast days.

Why is Ellen White's Understanding and Presentation of the Law of God So Different Than Walter Veith's and Doug Batchelor's???

Precepts Given to Guard Decalogue -

-In consequence of continual transgression, the moral law was repeated in awful grandeur from Sinai. Christ gave to Moses religious precepts which were to govern everyday life. **These statutes were explicitly given to guard the ten commandments. They were not shadowy types to pass away with the death of Christ. They were to be binding upon men in every age as long as time should last.** These commands were enforced by the power of the moral law, and they clearly and definitely explained that law.

(ST April 15, 1875 [Reprinted in RH May 6, 1875]). {1BC 1104.4}



Note: Upon examining the above quote we can safely conclude that the statutes and the ten commandments are two separate entities that work together for a common good. The statutes could be compared to the President's body guards and the Ten Commandments could be compared to the President. Just as the president always needs the protection of his body guards, so do the Ten Commandments always need the protection provided by the statutes. Furthermore, just as it would be dangerous to ignore or attack one of the President's bodyguards, so would it be very dangerous to attack or ignore any one of the statutes that were given to guard the Decalogue. So to claim fidelity to the fourth commandment of the Decalogue while simultaneously attacking or simply ignoring the statutes that were given to guard the fourth commandment, namely the feast days listed in Leviticus chapter 23, is like claiming respect for the President of the United States of America while simultaneously making a physical assault against any one of his bodyguards. In other words, anyone claiming to have respect for the fourth commandment of the Decalogue while simultaneously teaching against the observance of the annual Sabbath is a liar.

“It was represented to me that **the remnant** followed Jesus into the most holy place and beheld the ark and the mercy seat, and were captivated with their glory. Jesus then raised the cover of the ark, and lo! the tables of stone, with the ten commandments written upon them. **They trace down the lively oracles, but start back with trembling when they see the fourth commandment among the ten holy precepts, with a brighter light shining upon it than upon the other nine, and a halo of glory all around it.** They find nothing there informing them that the Sabbath has been abolished, or changed to the first day of the week. The commandment reads as when spoken by the voice of God in solemn and awful grandeur upon the mount, while the lightnings flashed and the thunders rolled; it is the same as when written with His own finger on the tables of stone: “Six days shalt thou labor, and do all thy work: but the seventh day is the Sabbath of the Lord thy God.” They are amazed as they behold the care taken of



the ten commandments. They see them placed close by Jehovah, overshadowed and protected by His holiness. They see that they have been trampling upon the fourth commandment of the Decalogue, and have observed a day handed down by the heathen and papists, instead of the day sanctified by Jehovah. They humble themselves before God and mourn over their past transgressions. {EW 255.1}



"I saw that **the holy Sabbath is, and will be, the separating wall between the true Israel of God and unbelievers, and that the Sabbath is the great question to unite the hearts of God's dear, waiting saints.** I saw that God had children who do not see and keep the Sabbath. They have not rejected the light upon it. And at the commencement of the time of trouble, we were filled with the Holy Ghost as we went forth and proclaimed the Sabbath more fully." Early Writings, p. 27

Note: We can easily understand from the above quote why the feast days are such a point of contention between Adventists that do observe the them and Adventists that teach against them. This is because the Sabbath and the feast days stand or fall together and those Adventists that are using their voice and pen to teach against God's feast days are actually teaching against the weekly Sabbath whether they realize it or not. Sadly, this doctrine of feast keeping has become a "separating wall between the true Israel of God and unbelievers," not because those of us that keep the feast days are building a wall of separation but because God Almighty is building a wall of separation between those who serve Him and those who serve Him not.

From time to time I have various friends and acquaintances ask me why it is that I place stronger emphasis upon the feast day statutes than I do upon other statutes listed in the Torah and my answer to this question is because God places a stronger emphasis upon the fourth commandment than he does upon the other nine and consequently the statutes that were given specifically to guard the fourth commandment deserve special emphasis as well. You see, it is not I that am placing special emphasis upon spending time with God when HE commands me to, it is God Himself that

places special emphasis upon our need of spending time with Him when He commands us to do so and Sr. White's vision proves this point.



"He did not even then trust His precepts to the memory of a people who were prone to forget His requirements, but wrote them upon tables of stone. He would remove from Israel all possibility of mingling heathen traditions with His holy precepts, or of confounding His requirements with human ordinances or customs. But He did not stop with giving them the precepts of the Decalogue. **The people had shown themselves so easily led astray that He would leave no door of temptation unguarded. Moses was commanded to write, as God should bid him, judgments and laws giving minute instruction as to what was required.** These directions relating to the duty of the people to God, to one another, and to the stranger were **only the principles of the Ten Commandments amplified** and given in a specific manner, that none need err. **They were designed to guard the sacredness of the ten precepts engraved on the tables of stone.** {PP 364.1}

Note: People today are just as easily led astray as were the ancient Israelites so I don't understand why God's people today are so arrogant as to imagine that they don't need the same statutes that God used to close the doors of temptation that the ancient Israelites so desperately needed. It is absolutely ridiculous to imagine that we are somehow holier today than they were back then and that we can safely walk on Satan's territory without falling into the same temptations that God instituted statutes to protect the ancient Israelites from. "Pride goes before destruction, a haughty spirit before a fall." Proverbs 16:18



"During the thousand years between the first and the second resurrection, the Judgment of the wicked takes place. The apostle Paul points to this Judgment as an event that follows the second advent. "Judge nothing before the time, until the Lord come, who both will bring to light the hidden things of darkness, and will make manifest the counsels of the hearts." [1 Corinthians 4:5.] Daniel declares that when the Ancient of days came, "Judgment was given to the

saints of the Most High." [Daniel 7:22.] At this time the righteous reign as kings and priests unto God. John in the Revelation says: "I saw thrones, and they sat upon them, and judgment was given unto them." "They shall be priests of God and of Christ, and shall reign with him a thousand years." [Revelation 20:4, 6; 1 Corinthians 6:2,3.] It is at this time that, as foretold by Paul, "the saints shall judge the world." [Revelation 20:4, 6; 1 Corinthians 6:2, 3.] In union with Christ they judge the wicked, comparing their acts with **the statute book, the Bible**, and deciding every case according to the deeds done in the body. Then the portion which the wicked must suffer is meted out, according to their works; and it is recorded against their names in the book of death." {GC88 660.3}

PLEASE TAKE NOTE

The above passage accurately describes the scenes of the judgment and explains in detail that those who love and obey Christ will walk in His statutes and will sit as judges with Christ of those who use their talents and influence to teach against the statutes like Walter Veith, Doug Batchelor and many, many bought and sold Seventh-day Adventist televangelists.

Those of us that sit as judges of the wicked statute breakers will be completely familiar with the statute book, the Bible and that is why we will be qualified to be judges with Christ and thus we will be capable of discerning the difference between good and evil, right and wrong, sweet and bitter, light and darkness. Without the statutes of God we are as good as blind dogs and cannot judge anything according to God's will.

When we sit as judges we will sentence with absolute confidence and accuracy people like Walter Veith because they chose to teach others not to keep the statutes/feast days. All religious leaders that were paid by their awestruck fans to teach lies about God's statutes will burn the longest.

Due to the seriousness of this subject I cannot overemphasize the importance of taking personal responsibility to become familiar with the statutes and brace yourself to face the opposition of 99.9% of all Seventh-day Adventists because almost all of them hate the statutes and follow their own customs and traditions rather than what the Bible and Ellen White clearly teach.

Please pray about this and consider standing with me as we teach the truth and expose satanic lies about God's law together.

When Satanic Lies are Taught by Adventist Leaders are We Not Obligated to Speak Out?!



"Ministers and people see that they have not sustained the right relation to God. They see that they have rebelled against the Author of all just and righteous law. **The setting aside of the divine precepts gave rise to thousands of springs of evil, discord, hatred, iniquity, until the earth became one vast field of strife, one sink of corruption.** This is the view that now appears to those who rejected truth and chose to cherish error. **No language can express the longing which the disobedient and disloyal feel for that which they have lost forever, --eternal life. Men whom the world has worshiped for their talents and eloquence now see these things in their true light. They realize what they have forfeited by transgression, and they fall at the feet of those whose fidelity they have despised and derided, and confess that God has loved them.** {GC88 655.3}

The people see that they have been deluded. They accuse one another of having led them to destruction; but all unite in heaping their bitterest condemnation upon the ministers. **Unfaithful pastors have prophesied smooth things; they have led their hearers to make void the law of God and to persecute those who would keep it holy.** Now, in their despair, these teachers confess before the world their work of deception. The multitudes are filled with fury. "We are lost!" they cry, "and you are the cause of our ruin;" and they turn upon the false shepherds. **The very ones that once admired them most, will pronounce the most dreadful curses upon them.** The very hands that once crowned them with laurels will be raised for their destruction. The swords which were to slay God's people are now employed to destroy their enemies. Everywhere there is strife and bloodshed. {GC88 655.4}

Note: The above quote is a description of the events to take place sometime in the future concerning those that fight against the statutes and persecute those of us that teach them. This passage explains that by the time most

Seventh-day Adventists realize that people like Walter Veith and Doug Batchelor are lying to them about the statutes and the Sabbath more fully message, it will be forever too late. Their fate is already sealed and they will turn on Walter Veith, Doug Batchelor and all of their various pastors that reassured them that they did not need to listen to those of us that were teaching the statutes and the feast days but it will not do them any good because they are already sealed into condemnation.



“God is now testing and proving His people. Character is being developed. Angels are weighing moral worth, and keeping a faithful record of all the acts of the children of men. Among God's professed people are corrupt hearts; but they will be tested and proved. That God who reads the hearts of everyone, will bring to light hidden things of darkness where they are often least suspected, that stumbling blocks which have hindered the progress of truth may be removed, and God have a clean and holy people to declare His **statutes and judgments**. {1T 332.3} The Captain of our salvation leads His people on step by step, purifying and fitting them for translation, and leaving in the rear those who are disposed to draw off from the body, who are not willing to be led, and are satisfied with their own righteousness”.

Note: The above statement makes it abundantly clear that those who teach against the statutes and judgment message are satisfied with their own righteousness.



“The **sacred statutes** which Satan has hated and sought to destroy, **will be honored throughout a sinless universe** (Patriarchs and Prophets, p. 342).



“To the very close of the controversy in heaven, the great usurper continued to justify himself. When it was announced that with all his sympathizers he must be expelled from the abode of bliss, then the rebel leader boldly avowed his contempt for the Creator's law. He denounced **the divine statutes** as a restriction of their liberty, and declared that it was his purpose to secure the abolition of law. With one accord, Satan and his host threw the blame of their rebellion wholly upon Messiah, declaring that if they had not been reprovved, they would never have rebelled. {GC 499.2}

When my fellow Seventh-day Adventists teach that the feast days are restricting their liberty in Christ the above passage always comes to mind. They are simply carrying forward Satan's original rebellion whether they know it or not.



When error in one garb has been detected, Satan only masks it in a different disguise, and multitudes receive it as eagerly as at the first.

When the people found Romanism to be a deception, and he could not through this agency lead them to transgression of God's law, he urged them to regard all religion as a cheat, and the Bible a fable; and **casting aside the divine statutes**, they gave themselves up to unbridled iniquity. {GC 285.1}



The discord which his own course had caused in Heaven, Satan charged upon the law and government of God. All evil he declared to be the result of the divine administration. He claimed that **it was his own object to improve upon the statutes of The Lord**. Therefore it was necessary that he should demonstrate the nature of his claims, and show the working out of his proposed changes in the divine law. His own work must condemn him. Satan had claimed from the first that he was not in rebellion. The whole universe must see the deceiver unmasked. {GC88 498.2}

NOTE: When my fellow Seventh-day Adventists tell me that their camp meetings are an adequate substitute for the feast days commanded by God in Leviticus chapter 23, the above passage always comes to mind. Certainly an omniscient, omnipotent, omnipresent God does not need his creatures to improve upon his statutes anymore than He needed Satan to improve upon them.



“In this age of the world, when Satan is seeking, through manifold agencies, to blind the eyes of men and women to the binding claims of the law of God, there is need of men who can cause many to "tremble at the commandment of our God" (Ezra 10:3). There is need of true reformers, who will point transgressors to the great Lawgiver and teach them that **"the law of**

The Lord is perfect, converting the soul" (Psalm 19:7). There is need of men mighty in the Scriptures, men whose every word and act **exalts the statutes** of The Lord, men who seek to strengthen faith. Teachers are needed, oh, so much, who will inspire hearts with reverence and love for the Scriptures. {PK 623.4}



“By the translation of Enoch The Lord designed to teach an important lesson. There was danger that men would yield to discouragement, because of the fearful results of Adam's sin. Many were ready to exclaim, "What profit is it that we have feared The Lord and have kept His ordinances, since a heavy curse is resting upon the race, and death is the portion of us all?" But the instructions which God gave to Adam, and which were repeated by Seth, and exemplified by Enoch, swept away the gloom and darkness, and gave hope to man, that as through Adam came death, so through the promised Redeemer would come life and immortality. Satan was urging upon men the belief that there was no reward for the righteous or punishment for the wicked, and that it was impossible for men to obey the **divine statutes**. But in the case of Enoch, God declares "that He is, and that He is a rewarder of them that diligently seek Him." Hebrews 11:6. He shows what He will do for those who keep His commandments. Men were taught that it is possible to obey the law of God; that even while living in the midst of the sinful and corrupt, they were able, by the grace of God, to resist temptation, and become pure and holy. They saw in his example the blessedness of such a life; and his translation was an evidence of the truth of his prophecy concerning the hereafter, with its award of joy and glory and immortal life to the obedient, and of condemnation, woe, and death to the transgressor. {PP 88.2}



“From the first the great controversy had been upon the law of God. Satan had sought to prove that God was unjust, that His law was faulty, and that the good of the universe required it to be changed. In attacking the law he aimed to overthrow the authority of its Author. In the controversy it was to be shown whether **the divine statutes** were defective and subject to change, or perfect and immutable. {PP 69.1}



“Says the prophet, "When Thy judgments are in the earth, the inhabitants of the world will learn righteousness. Let favor be showed to the wicked, yet will he not learn righteousness, . . . and will not behold the majesty of The Lord." Isaiah 26:9, 10. Thus it was after the Flood. Released from His judgments, the inhabitants of the earth again rebelled against The Lord. Twice God's covenant and **His statutes had been rejected by the world**. Both the people before the Flood and the descendants of Noah cast off the divine authority. Then God entered into covenant with Abraham, and took to Himself a people to become the depositaries of His law. To seduce and destroy this people, Satan began at once to lay his snares. The children of Jacob were tempted to contract marriages with the heathen and to worship their idols. But Joseph was faithful to God, and his fidelity was a constant testimony to the true faith. It was to quench this light that Satan worked through the envy of Joseph's brothers to cause him to be sold as a slave in a heathen land. God overruled events, however, so that the knowledge of Himself should be given to the people of Egypt. Both in the house of Potiphar and in the prison Joseph received an education and training that, with the fear of God, prepared him for his high position as prime minister of the nation. From the palace of the Pharaohs his influence was felt throughout the land, and the knowledge of God spread far and wide. The Israelites in Egypt also became prosperous and wealthy, and such as were true to God exerted a widespread influence. The idolatrous priests were filled with alarm as they saw the new religion finding favor. Inspired by Satan with his own enmity toward the God of heaven, they set themselves to quench the light. To the priests was committed the education of the heir to the throne, and it was this spirit of determined opposition to God and zeal for idolatry that molded the character of the future monarch, and led to cruelty and oppression toward the Hebrews. {PP 332.2}

During the forty years after the flight of Moses from Egypt, idolatry seemed to have conquered. Year by year the hopes of the Israelites grew fainter. Both king and people exulted in their power, and mocked the God of Israel. This grew until it culminated in the Pharaoh who was confronted by Moses. When the Hebrew leader came before the king with a message from "The Lord, God of Israel," it was not ignorance of the true God, but defiance of His power, that

prompted the answer, "Who is The Lord, that I should obey His voice? . . . I know not The Lord." From first to last, Pharaoh's opposition to the divine command was not the result of ignorance, but of hatred and defiance. {PP 333.1}

NOTE:

Never has there been a time when men were safe to cherish hatred and defiance of God's statutes. We all need to humble ourselves today and ask God to help us understand his statutes, the same statutes that Satan has been warring against ever since his rebellion in heaven.



"God's dealings with rebellion will result in fully unmasking the work that has so long been carried on under cover. The results of Satan's rule, **the fruits**

of setting aside the divine statutes, will be laid open to the view of all created intelligences. The law of God will stand fully vindicated. It will be seen that all the dealings of God have been conducted with reference to the eternal good of His people, and the good of all the worlds that He has created. Satan himself, in the presence of the witnessing universe, will confess the justice of God's government and the righteousness of His law. {PP 338.4}



"The records of sacred history declare, that while God is a God of justice, strict to mark iniquity, and strong to punish the sinner, he is also a God of truth,

compassion, and abundant mercy. **While he visits judgments upon the transgressors of his law and the enemies of his people, he will protect those who respect his statutes and show kindness to his chosen.**" {ST, August 24, 1882 par. 17}

Dear Reader,

Do you desire to escape the coming plagues that will destroy all those that fight against the truth as it is in Messiah? Then please heed this warning given in sincerity and brotherly concern. Stop fighting against the statute message with the feast days. Take a stand with God and His true statute seekers and against Satan and his forces. Begin studying and teaching the Eliyah message mentioned in the book of **Malachi chapter 4** today. I am not looking forward to witnessing your destruction by the plagues and again after the second resurrection in the lake fire simply because you were too proud to admit that you were falsely

educated by your leaders.

Please allow our loving heavenly Father to protect you from the plagues of Egypt. Fall on the Rock and be broken or the Rock will fall upon you and grind you to powder! Matthew 21:44 It will not be a pretty picture on judgment day if you continue to harden your heart against this timely and important truth. Please take note and pray about it. God can put a hedge around us and protect us like he did for Job, but **if we continue to fight against God's statutes we will forfeit his divine protection.** Remember that God is not mocked.

A Few Examples of New Testament Feast Keeping After the Cross (God Never Changes)

Below is an example of what God can do when we yield our will to his will, obey Him and keep the feast days as God commanded us to.

Acts chapter 2:1-8

"And when the day of Pentecost was fully come, they were all with one accord in one place. And suddenly there came a sound from heaven as of a rushing mighty wind, and it filled all the house where they were sitting. And there appeared unto them cloven tongues like as of fire, and it sat upon each of them. And they were all filled with the Holy Ghost, and began to speak with other tongues, as the Spirit gave them utterance. And there were dwelling at Jerusalem Jews, devout men, out of every nation under heaven. Now when this was noised abroad, the multitude came together, and were confounded, because that every man heard them speak in his own language. And they were all amazed and marveled, saying one to another, Behold, are not all these which speak Galilaeans? And how hear we every man in our own tongue, wherein we were born?"

Just as The Holy Spirit was poured out upon the disciples on the feast of Shavuot/Pentecost AFTER THE CROSS, so will the Holy Spirit be poured out upon us during some specific feast day in the future if we continue to walk in obedience to the appointed time statutes as the apostles did. Likewise, common sense also tells me that if we do not continue to obey God and keep the feast days then we will not receive the Holy Spirit as obedience to God is an absolute prerequisite to receiving the Holy Spirit.

"And we are his witnesses of these things; and so is also the Holy Ghost, whom God hath given to them that obey him." Acts 5:32

Jesus Kept The Feast of Unleavened Bread After the Cross

On the day Jesus resurrected he entered into the house of his disciples and blessed the bread they were eating which happened to be unleavened bread because it was during the feast of unleavened bread and they would not have had any other type of bread upon their table except for unleavened bread. Read Exodus chapter 12:15-20 for clarification.

"Seven days shall ye eat unleavened bread; even the first day ye shall put away leaven out of your houses: for whosoever eateth leavened bread from the first day until the seventh day, that soul shall be cut off from Israel. And in the first day [there shall be] an holy convocation, and in the seventh day there shall be an holy convocation to you; no manner of work shall be done in them, save [that] which every man must eat, that only may be done of you. And ye shall observe [the feast of] unleavened bread; for in this selfsame day have I brought your armies out of the land of Egypt: therefore shall ye observe this day in your generations by an ordinance forever. In the first [month], on the fourteenth day of the month at even, ye shall eat unleavened bread, until the one and twentieth day of the month at even. Seven days shall there be no leaven found in your houses: for whosoever eateth that which is leavened, even that soul shall be cut off from the congregation of Israel, whether he be a stranger, or born in the land. Ye shall eat nothing leavened; in all your habitations shall ye eat unleavened bread."

The feast days were kept by Yahushua after he died and resurrected which proves beyond a shadow of a doubt that Jesus did not abolish the feast days or "nail them to the cross." By his own actions of blessing the unleavened bread on the very day of his resurrection he demonstrated that God never changes and neither does his law or the times that he commands his children to meet with him and each other in accordance with Leviticus 23.

"But they constrained him, saying, Abide with us: for it is toward evening, and the day is far spent.

And he went in to tarry with them. And it came to pass, as he sat at meat with them, **he took bread, and blessed [it], and brake, and gave to them.** And their eyes were opened, and they knew him; and he vanished out of their sight." Luke 24:29-31

By His actions and example Yahushua sanctioned and encouraged the continued celebration of the feast of unleavened bread in the new testament era. By blessing and breaking the unleavened bread that was on the table of the disciples after he was crucified and resurrected Jesus was giving us an example of continuing the celebration of the feast of unleavened bread. Seeing that after His resurrection Yahushua/Jesus continued to keep the feast of unleavened bread and blessed the celebration of the feast of unleavened bread, why should we do any different?

When reading the below passages remember that all of this took place AFTER the cross and that the Jews would never have placed leavened bread upon their tables during the feast of unleavened bread. In fact, they would not have had leavening anywhere in their entire home because it was forbidden by the law that Doug Batchelor teaches was nailed to the cross and done away with. Please keep in mind that this meal was eaten AFTER the cross and never did Jesus tell his disciples that it was no longer required to observe the feast of unleavened bread.



"And it came to pass, as he sat at meat with them, he took bread, and blessed it, and brake, and gave to them. And their eyes were opened, and they knew him; and he vanished out of their sight. Luke 24:30, 31. {CTr 297.1}

The simple evening meal of bread is prepared. It is placed before the Guest, and He puts forth His hands to bless the food. Why do the disciples start back in astonishment? Their companion spreads forth His hands in exactly the same way as their Master used to do. They look again, and lo, they see in His hands the print of nails. Both exclaim at once, It is the Lord Jesus. He has risen from the dead. {CTr 297.2}

They rise to cast themselves at His feet and worship Him. But He has vanished out of their sight. They look at the space that had been occupied by One whose body had lately lain in the grave, and say to each other, "Did not our heart burn within us, while he talked with us by the

way, and which he opened to us the scriptures?"
{CTr 297.3}

So even though I am in the minority in my beliefs on this subject among my Seventh-day Adventist brethren, I have purposed in my heart to continue to follow Jesus' example and keep the feast days just like He did AFTER THE CROSS.

Imitating Christ, The Apostle Paul Kept the Feast Days As Well

What my fellow Seventh-day Adventists seem to conveniently forget is that the apostle Paul (their favorite "anti feast day teacher") taught us very clearly that we should keep the feast days.

Here are just a couple of many examples.



"Therefore let us keep the feast, not with old leaven, neither with the leaven of malice and wickedness; but with the unleavened [bread] of sincerity and truth." 1 Corinthians 5:8

If we read 1 Corinthians chapter 5 in context Paul was encouraging the Corinthians to keep the feast of unleavened bread but not while fornicating with one's own stepmother. Believers in the Messiah should never behave worse than the heathens during any season of the year but especially during the feast of unleavened bread! We should celebrate the feast of unleavened bread but celebrate it with "clean hands and a pure heart." Psalms 24:4

"According to the SDA Bible Commentary, the tensing of the Greek word translated 'keep' in the phrase, 'Therefore let us keep the feast,' is 'continue keeping.' (S.D.A. Bible Commentary, vol. 6, page 691) Therefore, the phrase should read, 'Therefore let us continue keeping the feast [of Unleavened Bread].' The idea of the 'continuation' of keeping the Feast of Unleavened Bread asserts that there was an already existing observance of the Feast of Unleavened Bread which is to 'continue.'"

"He that saith he abideth in him ought himself also so to walk, even as he walked." 1 John 2:6

We must remember Yahushua/Jesus never told the Pharisees to stop being Pharisees, He simply wanted them to place proper emphasis upon loving their neighbor as themselves and obeying all of Moses' law and not just the smaller issues like tithing their herb garden.

"Woe to you, teachers of the law and Pharisees, you hypocrites! You give a tenth of your spices--mint, dill and cummin. But you have neglected the more important matters of the law--justice, mercy and faithfulness. You should have practiced the latter, without neglecting the former." Matthew 23:23

"And we sailed away from Philippi after the days of unleavened bread, and came unto them to Troas in five days; where we abode seven days." Acts 20:6



"At Philippi Paul tarried to keep the Passover. Only Luke remained with him, the other members of the company passing on to Troas to await him there. The Philippians were the most loving and truehearted of the apostle's converts, and **during the eight days of the feast** he enjoyed peaceful and happy communion with them." {AA 390.4}

After Paul kept the feast of unleavened bread with his Gentile Philippian converts he wrote them and told them to continue to follow his example.

"Whatever you have learned or received or heard from me, or seen in me--put it into practice. And the God of peace will be with you." Phil 4:9

Most of my fellow Adventists also seem to conveniently overlook the fact that the Apostle Paul told us that the Jews are **ADVANTAGED** in **EVERY** way.

"What advantage then hath the Jew? or what profit [is there] of circumcision? Much **EVERY** way: **CHIEFLY**, because that unto them were committed the oracles of God." Romans 3:1-2

When I listen to the various Seventh-day Adventist televangelists speak, in general **it sounds like they read Paul to say that the Jews are DISADVANTAGED in EVERY way and CHIEFLY because they keep the feast days.** In

reality, the feast days are what give the Jews the advantage Paul is talking about because the feast days allow the Jews to spend more time with God and this is why Satan hates it when God's true, remnant people celebrate the feast days, and he uses the leaders of the Seventh-day Adventist corporate structure to shame us for doing so. **Sadly, these "holy" men of the cloth sing "JUST A CLOSER WALK WITH THEE" and then teach against the observance of the very divine worship institutions given by God to help us have that closer walk!** As our Messiah reminded us "It is written, Man shall not live by bread alone, but by every word that proceedeth out of the mouth of God." **If this is true, and it most certainly is, then those preachers that tell us that we no longer need to walk in the statutes of the Torah, which proceeded directly from the mouth of God (Deuteronomy 5:31)have deprived us of the necessities of life. "Keeping the Sabbath Days And Annual Biblical Festivals Holy is Not a Doctrine of Men!"

Paul was not doing away with God's commandment; he was warning against the false teachers who were saying believers must keep the festivals, new moons, and Sabbaths according to certain human regulations. The question we need to ask is this: Was Paul condemning the Sabbath

day, or was he condemning the doctrines of men who added ritualistic and ascetic restrictions to faith in Christ?

In order to answer that dispute, one must look at the broad picture. There is not a single verse in the New Testament which states that Paul taught a new doctrine that canceled the Sabbath commandment; nor is there any record of a controversy between the Jews and Gentile Christians over Sabbath-keeping. If Paul had been teaching that the Sabbath commandment had been repealed, it would have split the Church wide open, and he would have had to answer the objections continuously in his epistles. Think about it. If the Jewish believers made such a fuss about circumcision being optional, imagine what they would have said about the Sabbath day being revoked.

At some point we must use common sense and reason to interpret what has been written. For example, does "Let no man judge you in meat and drink" mean that Christians can be gluttons and drunkards? Of course not, because you know that God's Word forbids gluttony and drunkenness. Well, it also forbids Sabbath-breaking!

It is only logical to assume that if God was going to cancel one of His Ten Commandments, He would make that fact very clear. Surely, if someone said to you, Let no man judge you in respect of murder or adultery you would not assume that God had changed His mind about those sins without solid proof. Certainly, you would demand more evidence than one lonely verse in the book of Colossians. Or would you?

In addition to the Greek and Latin manuscripts of the New Testament, there is a third text called the Peshitta. The Peshitta (the oldest dated manuscript known) is from ancient Eastern manuscripts written in Aramaic, the natural language of Jesus. Hebrews 4:9 in the Peshitta text reads: It is therefore the duty of the people of God to keep the Sabbath."

Ellen White's commentary on Matthew 5:17



"On the mount, Jesus was closely watched by spies; and as He unfolded the principles of righteousness, the Pharisees caused it to be whispered about that His teaching was in opposition to the precepts that God had given from Sinai. The Saviour said nothing to unsettle faith in **the religion and institutions that had been given through Moses; for every ray of divine light that Israel's great leader communicated to his people was received from Christ.** While many are saying in

their hearts that He has come to do away with the law, Jesus in unmistakable language reveals **His attitude toward the divine statutes**. "Think not," He said, "that I am come to destroy the law, or the prophets." {MB 47.1}

Note: **Sister White did NOT make the claim as most Seventh-day Adventists do that Jesus was referencing only the ten commandments in this passage but she specifically tells us that Jesus was talking about the statutes written in the law of Moses. The very statutes that Doug Batchelor teaches were done away with.** Sister White continues.....

"It is the Creator of men, the Giver of the law, who declares that it is not His purpose to set aside its precepts. Everything in nature, from the mote in the sunbeam to the worlds on high, is under law. And upon obedience to these laws the order and harmony of the natural world depend. So there are great principles of righteousness to control the life of all intelligent beings, and upon conformity to these principles the well-being of the universe depends. Before this earth was called into being, God's law existed. Angels are governed by its principles, and in order for earth to be in harmony with heaven, man also must obey the divine statutes. To man in Eden Christ made known the precepts of the law "when the morning stars sang together, and all the sons of God shouted for joy." Job 38:7. **The mission of Christ on earth was not to destroy the law, but by His grace to bring man back to obedience to its precepts.** {MB 48.1}

The beloved disciple, who listened to the words of Jesus on the mount, writing long afterward under the inspiration of the Holy Spirit, speaks of the law as of perpetual obligation. He says that "sin is the transgression of the law" and that "whosoever committeth sin transgresseth also the law." 1 John 3:4. He makes it plain that the law to which he refers is "an old commandment which ye had from the beginning." 1 John 2:7. He is speaking of the law that existed at the creation and was reiterated upon Mount Sinai. {MB 48.2}

Speaking of the law, Jesus said, "I am not come to destroy, but to fulfill." He here used the word "fulfill" in the same sense as when He declared to John the Baptist His purpose to "fulfill all righteousness" (Matthew 3:15); that is, to fill up the measure of the law's requirement, to give an example of perfect conformity to the will of God. {MB 48.3}

His mission was to "magnify the law, and make it honorable." Isaiah 42:21. He was to show the

spiritual nature of the law, to present its far-reaching principles, and to make plain its eternal obligation. {MB 49.1}

The divine beauty of the character of Christ, of whom the noblest and most gentle among men are but a faint reflection; of whom Solomon by the Spirit of inspiration wrote, He is "the chiefest among ten thousand, . . . yea, He is altogether lovely" (Song of Solomon 5:10-16); of whom David, seeing Him in prophetic vision, said, "Thou art fairer than the children of men" (Psalm 45:2); Jesus, the express image of the Father's person, the effulgence of His glory; the self-denying Redeemer, throughout His pilgrimage of love on earth, was a living representation of the character of the law of God. In His life it is made manifest that heaven-born love, Christlike principles, underlie the laws of eternal rectitude.

"Till heaven and earth pass," said Jesus, "one jot or one tittle shall in no wise pass from the law, till all be fulfilled." By His own obedience to the law, Christ testified to its immutable character and proved that through His grace it could be perfectly obeyed by every son and daughter of Adam. On the mount He declared that not the smallest iota should pass from the law till all things should be accomplished--all things that concern the human race, all that relates to the plan of redemption. He does not teach that the law is ever to be abrogated, but **HE FIXES THE EYE UPON THE UTMOST VERGE OF MAN'S HORIZON AND ASSURES US THAT UNTIL THIS POINT IS REACHED THE LAW WILL RETAIN ITS AUTHORITY SO THAT NONE MAY SUPPOSE IT WAS HIS MISSION TO ABOLISH THE PRECEPTS OF THE LAW.** So long as heaven and earth continue, the holy principles of God's law will remain. His righteousness, "like the great mountains" (Psalm 36:6), will continue, a source of blessing, sending forth streams to refresh the earth. {MB 49.3}

Because the law of the Lord is perfect, and therefore changeless, **IT IS IMPOSSIBLE FOR SINFUL MEN, IN THEMSELVES, TO MEET THE STANDARD OF ITS REQUIREMENT. THIS WAS WHY JESUS CAME AS OUR REDEEMER. IT WAS HIS MISSION, BY MAKING MEN PARTAKERS OF THE DIVINE NATURE, TO BRING THEM INTO HARMONY WITH THE PRINCIPLES OF THE LAW OF HEAVEN.** When we forsake our sins and receive Christ as our Saviour, the law is exalted. The apostle Paul asks, "Do we then make void the law through faith? God forbid: yea, we establish the law." Romans 3:31. {MB 50.1} "Forever, O Lord, Thy word is settled in heaven."

"All His commandments are sure. They stand fast for ever and ever, and are done in truth and uprightness." "Concerning Thy testimonies, I have known of old that Thou hast founded them forever." Psalm 119:89; 111:7, 8; Psalm 119:152. {MB 51.1}

"Whosoever . . . shall break one of these least commandments, and shall teach men so, he shall be called the least in the kingdom of heaven." Matthew 5:19

That is, he shall have no place therein. For he who willfully breaks one commandment, does not, in spirit and truth, keep any of them. "Whosoever shall keep the whole law, and yet offend in one point, he is guilty of all." James 2:10. {MB 51.2}


